### **Additional Information**

- Any Payment made for the Prestige Wedding Extravaganza is non-refundable. Refunds will not be issued for any reason.
- Certificate of Liability: Your business must provide a certificate of liability insurance naming Prestige Productions and the Davenport Country Club as additional insured. COL must be submitted to Prestige Productions no later than TWO weeks prior to show.
- Final payments must be made no later than one week prior to show NO EXCEPTIONS
- · Non-payment will result in forfeiture of your booth space.
- Event organizers reserve the right to place all exhibitors at their discretion.
- Show hours are 9am-3pm. All booths need to be fully staffed during show hours.
- Early breakdowns are NOT permitted Early breakdowns not only cause you to lose out on potential business, but it leaves a negative impression about the show on our brides and will not be tolerated.

## **Set- Up Information:**

Friday 12p-6p Saturday 5am-9am

### **Tear Down Information:**

 May NOT begin until the show has concluded at 3pm and must be completed immediately following the show.

#### **Booths:**

- Signage is NOT provided for your booth.
- Booth spaces are roughly 8'x 8' & include a 6' table and 2 chairs. Additional Charges are required for extra tables or extra booth space.
- · Wireless Internet is included in all booth packages.
- Electrical hook ups ARE included but requests MUST be made by January 15, 2018.

## **Advertising:**

- A general advertising package will be provided by "The PWE" that promotes the event. This may include posters, websites, tickets, Facebook, print media, radio, and television.
- To be included in the advertising poster, your contract must be received no later than January 15th, 2018. No discount is given for vendors signing up for the Bridal Expo and missing the advertising deadline.

**STIPULATIONS:** I understand that as a vendor, I will participate in The Prestige Wedding Extravaganza on Saturday, February 24, 2018 and agree to the following:

- That to guarantee the right to a booth a signed contract and full payment must be received by "The PWE" If not paid in full, my business forfeits the right to the booth and "The PWE" has the right to immediately release the booth for resale.
- That all payments to the The Prestige-Wedding Extravaganza are non-refundable. No refunds will be issued for any reason.
- That the Bridal Expo will take place under all weather conditions, barring decision by the Davenport Country Club to close. In the event the DCC closes due to weather, no refund will be given. If our obligations under the contract are not met for any reason beyond our control, our failure is completely excused and we may cancel the contract and no refund will be issued. This includes but is not limited to strikes, labor disputes, accidents, government restrictions on travel, venue operations, goods or supplies, act of war, and acts of God.
- That my business will be given the right to use the Prestige-Wedding Extravaganza lead list
  that will be accumulated from the bridal show participants. This may be used in advertising
  my business but may not be resold, given, or distributed to any other person or business for
  any reason. The list is the property of "The PWE". No guarantees are given for 100% correct
  information given to "The PWE" participants.
- That I will be allowed to give away free samples from my booth location. Some events may
  require special licenses and it is the client's responsibility to acquire all specific authorizations
  and permits through that particular agency. This includes the Scott County Health
  Department and Iowa Alcoholic Beverages Division.

- I will not be able to block the aisles or go outside the boundaries of the booth with tables, trays, noise, or salespeople.
- That there will be only one contract for booths accepted for The PWE from each home party company. Booth contracts will be given on a first come first serve basis in this instance once full payment is received.
- That contacting other vendors participating in The PWE to offer additional services will not be permitted without obtaining permission of The Prestige-Wedding Extravaganza.
- That I will not be able to sublet or sell any part of the booth I purchase to any vendor, business, or individual. From my booth I am only able to promote my own product or service and no other business. If I am a representative for another business, I may only have their name mentioned in the fliers or advertising of my own business and may not give away their fliers or business cards separately or put in as inserts. No equipment or representative from another business that does not have a booth in The PWE may be present in my booth at any time. Stated simply, you are only allowed to promote your one product or service from your one booth; two services, two booths, etc. Anyone breaking these rules will be asked to remove the item in question. If a second request is required, the vendor will be expelled from the facilities immediately without any refund.
- That if any of the above sections of this contract are violated, I will be expelled from The PWE immediately. I understand that if The PWE does this, I will not be refunded any portion of my payment. Should any legal action be commenced related to this contract the vendor shall be responsible for all costs and attorney fees incurred by The Prestige- Wedding Extravaganza.
- The vendor assumes the entire responsibility and liability including but not limited to
  judgments, awards for damages, equitable relief and defense costs, and for any and all
  claims or causes of action that may be brought against The PWE as a result of the conduct of
  the vendor, including the conduct of any vendor's employees or guests. The vendor releases
  and holds harmless The PWE from any and all such cost, loss, damage, expense,
  responsibility, or liability.
- The parties agree that in the event of a breach, either of them may pursue any remedies available not inconsistent with this agreement, either in law or equity, and jurisdiction and venue shall be proper in Scott County, Iowa. The breaching party shall be responsible for all costs incurred as a result of such breach, (i.e. returned check fee of \$25), or in order to enforce the agreement, including but not limited to all reasonable attorney fees and costs incurred by the non-breaching party.
